Becoming a Candidate Member of CREIA is *easy*. Fill out this application fully making sure you **sign** and **date** the bottom of form. Then either mail or fax (760) 318-2117 it to our office. You will be encouraged to upgrade your Candidate status to a CERTIFIED CREIA INSPECTOR (CCI) Member within twelve (12) months. Upgrading your Candidate status involves the following four (4) requirements:

1. Attain/document thirty (30) continuing education credits (CECs) which are secured by attendance at industry related seminars, educational programs, CREIA conferences or CREIA Chapter meetings.
2. Attend two (2) of your local CREIA Chapter meetings.
3. Pass the California Home Inspector Exam (CHIE), *includes questions on CREIA Code of Ethics*.
4. Participate in the CREIA Mentoring Program with a **RideAlong** with approved CREIA mentor and **one** of the following:
 1. Have a copy of one of your current Inspection Reports reviewed by an approved CREIA mentor
 2. Take part in a parallel inspection with an approved CREIA mentor on a property

Once you have successfully passed all the above requirements you will be entitled to use the CERTIFIED CREIA INSPECTOR (CCI) designation and logo on your business and marketing materials. We strongly urge you to seek this CERTIFIED CREIA INSPECTOR (CCI) Member status so that we can recognize and refer you to REALTORS® and consumers seeking a CERTIFIED CREIA INSPECTOR (CCI) Member.
