I acknowledge that I have read and understand the terms of this release.

I hereby expressly waive any and all rights conferred upon me by Section 1542 of the California Civil Code, which provides:

“A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE CREDITOR DOES NOT KNOW OR SUSPECT TO EXIST IN HIS FAVOR AT THE TIME OF EXECUTING THE RELEASE, WHICH IF KNOWN BY HIM MUST HAVE MATERIALLY AFFECTED HIS SETTLEMENT WITH THE DEBTOR.”

I acknowledge that there is a risk that after I sign this release I will discover facts or will discover claims that were unknown or unsuspected when I signed this agreement, and that if I had known about them before I signed this agreement it may have materially affected my decision to sign this release. I agree that I am assuming the risk of such unknown facts and claims and that I intend and agree that this release applies to all claims including known claims as well as claims which are unknown or not suspected at the time I signed this release. I understand the effect of my waiver of rights under Section 1542, quoted above. I agree that in any court proceeding or arbitration to enforce the terms of this release agreement, the prevailing party shall be entitled to an award of reasonable costs and attorneys fees.
